Minimum Disclosure Document

Investment objective

The Maestro Equity Fund will be a general equity portfolio. The Manager in selecting securities for the portfolio will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Maestro Equity Fund, shall comprise a mix of securities, financially sound ordinary shares, stock, financially sound preference shares, debenture stock, debenture bonds and unsecured notes as defined in the Act and the Deed, all to be acquired at a fair market value.

The Fund benchmark

The Fund will measure itself against the FTSE-JSE All Share Index. ASISA Classification: South African-Equity-General.

Legal structure

The Fund is a scheme in the nature of a trust known as a collective investment scheme. The portfolio manager is Maestro Investment Management (Pty) Ltd, an approved Financial Services Provider in terms of the Financial Advisory and Intermediary Services Act, operating under license number 739. This portfolio operates as a white label fund under the Prescient unit Trust Scheme, which is governed by the Collective Investment Schemes Control Act.

Fee structure

The maximum initial fee is 2.0%. The annual investment management fee is 1.75%. The annual total expense ratio (TER) for period ended 31 December 2019, in respect of class A was 2.42%.

Market Overview

You don't need me to tell you we are living in truly remarkable times. As the world continues to struggle with the Covid pandemic, which seems to be gaining a second wind in certain countries, the familiar US antagonism towards anything Chinese raised its ugly head again. Under the current circumstances market returns across various countries make for interesting reading.

During June, most markets posted gains. The MSCI World index rose 2.5%, the US market rose 2.0%, Germany 6.3% and Hong Kong 6.4%. The Indian equity market rose 7.7% and in China 4.6%, helping the MSCI Emerging Market index gain 7.0% during June; Turkey rose 10.4% and Brazil 8.8%, which didn't do any harm. But India and Hong Kong posted weak returns in May, illustrating the point that short-term movements are often a function of low bases created in preceding periods.

The dollar declined 1.0% during June, after declining 0.7% in May, however the dollar is still up 1.3% for the year to date. The oil price, which rose another 16.7%, after adding 38.4% last month, is still down 36.6% for the year. The price of copper rose 12.2%, silver 3.3%, gold 3.2% and Iron Ore 0.2%. On the currency front, emerging market currencies were mixed, while the rand strengthened 1.5%. Within global bond markets, the returns were positive for the third straight month in a row. The Bloomberg Aggregate Global Bond index rose 0.9%, bringing its annual gain for the year to 3.0%; the MSCI World index is down 6.6% during the same time period.

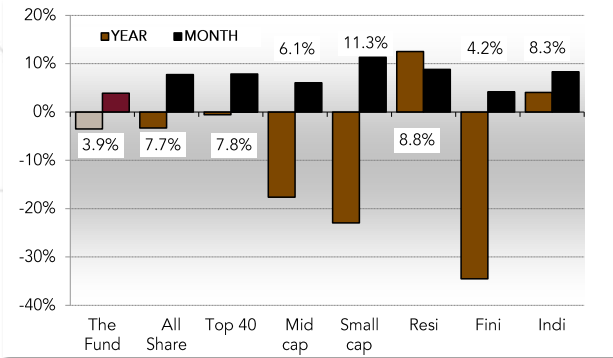

Local market returns

Turning to the South African market, it rose 7.7%, which was pushed higher by most sectors. The Basic Materials index rose 8.8%, boosted again by a weaker dollar. The Industrial index rose 8.3% and the Financial index rose 4.2%. The Industrial Index is up 4.0% over the past year, while the Financial Index is down 34.5%. The Mid and Small cap indices ended the month up 6.1% and 11.3% respectively. The rand firmed 1.5% against the dollar during the month. The All Bond index declined 1.2%; its annual return to end-June is only 0.4%.

Investment manager comment

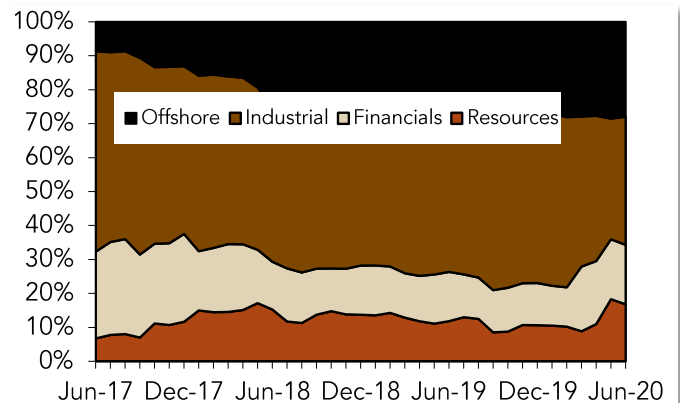
The return on the Fund was 3.9% for the month versus the 7.7% All Share index return. Shares which disappointed during the month included Firstrand, which lost 5.2%, MTN lost 2.0% and Ninety One 1.3%. Shares that rose during the month included Transaction Capital, which rose 8.7%, Prosus 12.9%, Naspers 13.4%, and Cashbuild 21.6%.

There were no major investment transactions during the month.

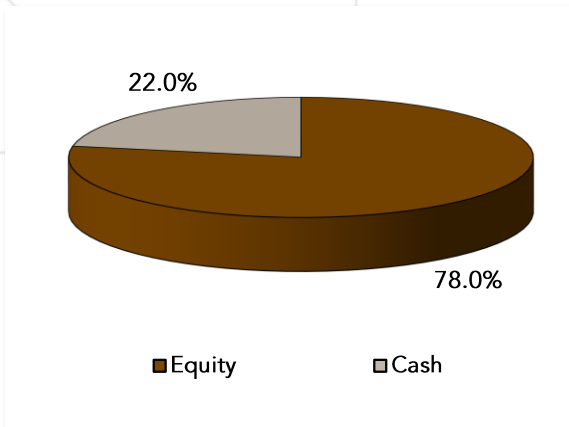

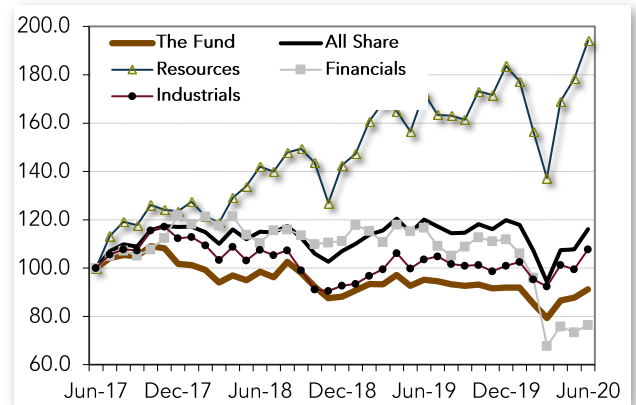
