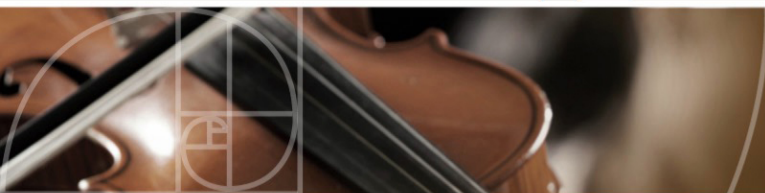

Minimum Disclosure Document & General Investor Report

### Investment objective

The Maestro Equity Prescient Fund will be a general equity portfolio. The Manager in selecting securities for the portfolio will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Maestro Equity Prescient Fund, shall comprise a mix of securities, financially sound ordinary shares, stock, financially sound preference shares, debenture stock, debenture bonds and unsecured notes as defined in the Act and the Deed, all to be acquired at a fair market value.

### The Fund benchmark

The Fund will measure itself against the FTSE-JSE All Share Index.  
ASISA Classification: South African-Equity-General.

### Legal structure

The Fund is a scheme in the nature of a trust known as a collective investment scheme. The portfolio manager is Maestro Investment Management (Pty) Ltd, an approved Financial Services Provider in terms of the Financial Advisory and Intermediary Services Act, operating under license number 739. This portfolio operates as a white label fund under the Prescient unit Trust Scheme, which is governed by the Collective Investment Schemes Control Act.

### Fee structure

The maximum initial fee is 2.0%. The annual investment management fee is 1.75%. The annual total expense ratio (TER) for period ended 30 September 2021, in respect of class A was 2.57%.

## Market Overview

Investment markets continued to decline during September as investor fears worsened on the back of aggressive central bank action around the world.

Despite the significant losses on investment markets so far this year, the market declines accelerated during the month; the MSCI World and Emerging Market indices declined by 9.5% and 11.9% respectively. The MSCI World index has now lost 26.4% so far this year. The US equity market fell 9.2%, the tech-heavy NASDAQ lost 10.5%, and the German and Swiss markets lost 5.6% and 5.4% respectively. The Hong Kong market fell 13.7%, to take its annual loss to 29.9%.

The strong dollar was a major influence during the month. It pushed just about all currencies and commodity prices lower. It rose 3.1% against a basket of major trading partners, while the euro and pound lost 2.6% and 4.1% against the greenback. The rand lost 5.2% against the dollar.

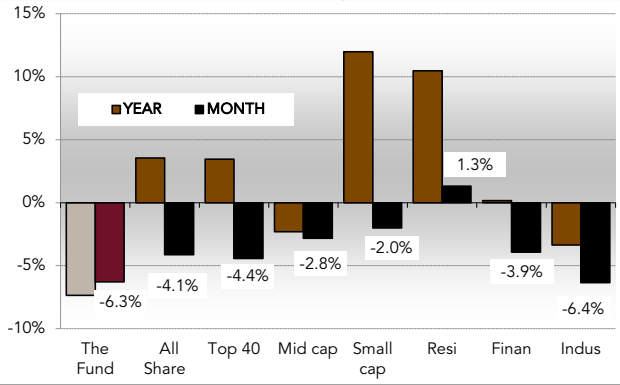
Global bond markets didn't fare particularly well either, posting the kind of losses, and displaying volatility, that are more typically associated with equity markets. The Bloomberg Global Aggregate Bond index lost 5.1% on the month, bringing its year-to-date loss to 19.9% - the worst "start" to a year on record.

**Local market returns**

The All Share index lost 4.1% during September. The Basic Material, Financial and Industrial indices posted September returns of 1.3%, -3.9%, and -6.4% respectively. The Top40 (large cap), Mid and Small indices lost 4.4%, 2.8%, and 2.0% respectively, while the All Bond index lost 2.1%.

All things considered, the SA bond market held up relatively well; it has posted an annual gain to end-September of 1.5%, which compares favourably to the loss of the global bond market of 20.4% over the same period, although of course the rand has weakened 16.3% over the same period.

**Investment Manager comment**

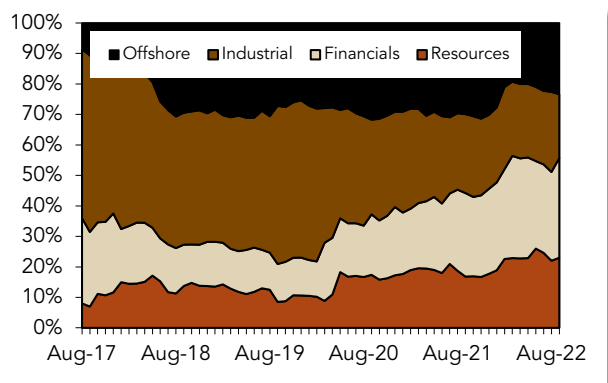
Shares which disappointed included Capitec, which declined 24.0% on the month, Discovery fell 14.6%, Sasol 13.9%, Cashbuild 12.3%, Richemont 11.2% and Aspen 9.0%. On a more positive note, Stor-Age Property only lost 1.1%, while BHP Billiton rose 4.0% and Afrocentric 4.9%.

There were no significant investment transactions during the month.

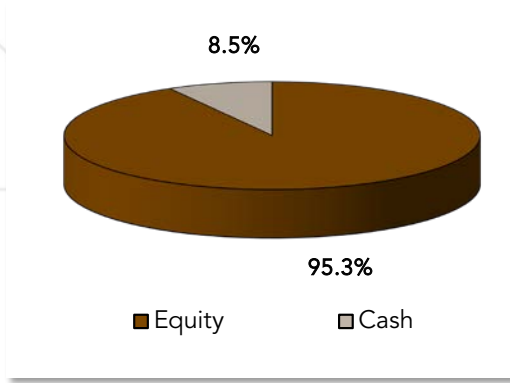

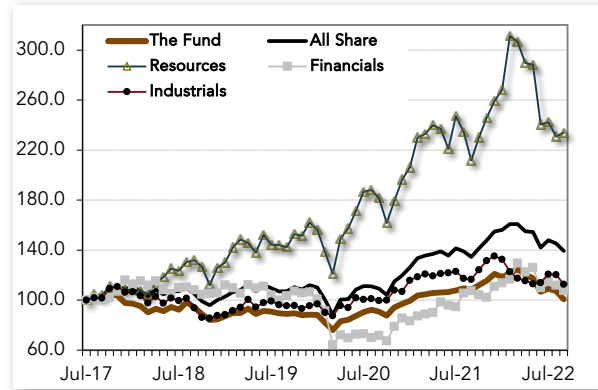
