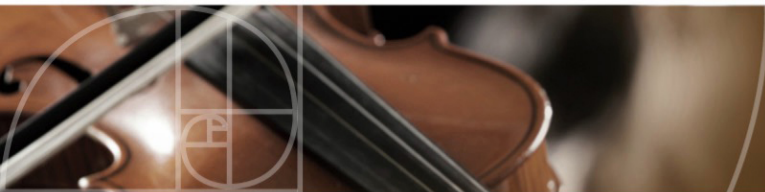

Minimum Disclosure Document & General Investor Report

Investment objective

The Maestro Equity Prescient Fund will be a general equity portfolio. The Manager in selecting securities for the portfolio will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Maestro Equity Prescient Fund, shall comprise a mix of securities, financially sound ordinary shares, stock, financially sound preference shares, debenture stock, debenture bonds and unsecured notes as defined in the Act and the Deed, all to be acquired at a fair market value.

The Fund benchmark

The Fund will measure itself against the FTSE-JSE All Share Index.
ASISA Classification: South African-Equity-General.

Legal structure

The Fund is a scheme in the nature of a trust known as a collective investment scheme. The portfolio manager is Maestro Investment Management (Pty) Ltd, an approved Financial Services Provider in terms of the Financial Advisory and Intermediary Services Act, operating under license number 739. This portfolio operates as a white label fund under the Prescient unit Trust Scheme, which is governed by the Collective Investment Schemes Control Act.

Fee structure

The maximum initial fee is 2.0%. The annual investment management fee is 1.75%. The annual total expense ratio (TER) for period ended 30 September 2021, in respect of class A was 2.57%.

Market Overview

Investor concerns around global inflation continue to determine the direction and momentum of equity and bond markets. While the underlying US inflation data is starting to look just a bit more benign, the perceived hawkish (aggressive) comments by US Fed Governor Jerome Powell triggered a sharp downward correction to US and other markets, and a commensurate rise in bond yields (and decline in prices). However, when all was said and done, global equity markets managed to move into positive territory for the month, with the exception of China and Hong Kong.

The MSCI World index gained 7.1% in October, with the US equity market rising 8.1% and the German DAX index 9.4%. The year-to-date returns remain very negative though, at -21.2%, -17.7%, and -16.7% respectively. The Swiss market, traditionally a defensive one, rose 5.5%, while the NASDAQ index lagged quite badly, rising "only" 3.9%. The NASDAQ's year-to-date return remains deeply negative, at -29.8%. The MSCI Emerging Market index *declined* 3.2% - in stark contrast to the MSCI World index *gain* of 7.1%, a difference of 10.3% in one month!

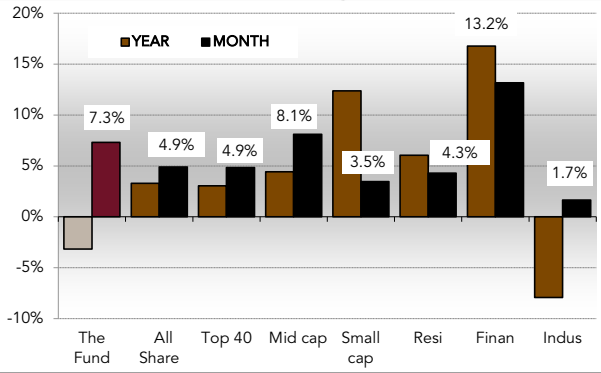
Global bond markets remained under pressure, although they ended October off their worst levels. The Bloomberg Global Aggregate Bond index lost another 0.7% and is now down 20.4% so far this year. The dollar ended the month slightly (-0.5%) weaker on the month. Commodity prices were mixed, with gains and losses spread randomly across the complex.

Local market returns

The positive sentiment on global markets spilled over onto local equity markets, other than the industrial sector, which continues to be heavily influenced by Hong Kong-listed Tencent. The latter constitutes the bulk of index heavyweight Nasper’s value.

The All Share index rose 4.9%, supported by the Basic Material index gain of 4.3% and a mouth-watering gain of 13.2% by the financial sector. The Large (Top40), Mid and Small cap indices rose 4.9%, 8.1% and 3.4% respectively. The All Bond index rose 1.1%, bring its year-to-date loss to only 0.3%, which makes it rather unique when compared to the global bond market year-to-date return of -20.4%.

Investment Manager comment

The Maestro Prescient Equity Fund rose 7.3% during October versus the All Share index rise of 4.9%. Shares which disappointed included BHP Billiton, which declined 5.7%, while Cashbuild lost 3.9%. Aspen rose 3.3% in October, Discovery 14.8%, Standard Bank 18.3%, Ninety One 18.6%, Afrocentric 22.4% and Capitec 22.4%.

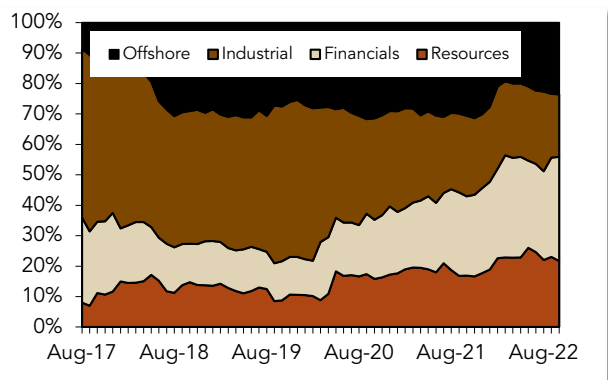
At the end of the month 92.7% of the Fund’s assets were committed to the equity market, while the balance of 7.3% is being retained in cash.

The Fund has adhered to its Policy document during the month.

Historic sector allocation (% of Equity)

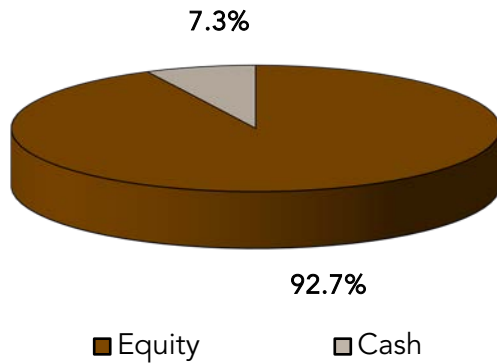




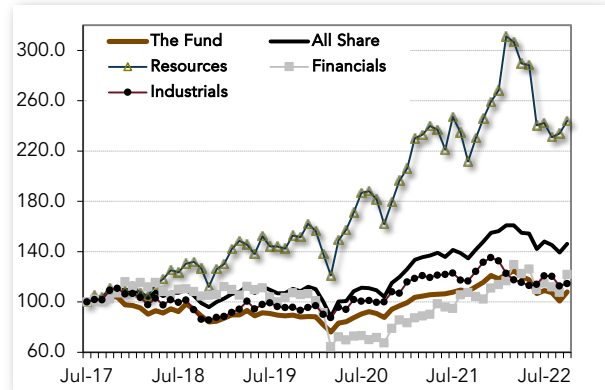
