Minimum Disclosure Document & General Investor Report

Investment objective

The Maestro Equity Prescient Fund will be a general equity portfolio. The Manager in selecting securities for the portfolio will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Maestro Equity Prescient Fund, shall comprise a mix of securities, financially sound ordinary shares, stock, financially sound preference shares, debenture stock, debenture bonds and unsecured notes as defined in the Act and the Deed, all to be acquired at a fair market value.

The Fund benchmark

The Fund will measure itself against the FTSE-JSE All Share Index.
ASISA Classification: South African-Equity-General.

Legal structure

The Fund is a scheme in the nature of a trust known as a collective investment scheme. The portfolio manager is Maestro Investment Management (Pty) Ltd, an approved Financial Services Provider in terms of the Financial Advisory and Intermediary Services Act, operating under license number 739. This portfolio operates as a white label fund under the Prescient unit Trust Scheme, which is governed by the Collective Investment Schemes Control Act.

Fee structure

The maximum initial fee is 2.0%. The annual investment management fee is 1.75%. The annual total expense ratio (TER) for period ended 31 December 2022, in respect of class A was 2.31%.

Market Overview

The Bloomberg Global Aggregate Bond index rose 3.3% in January, bringing its annual return to end-January to -11.7%. Expectations of a slow down in the rate at which US interest rates are rising led to a weaker dollar; the dollar "DXY" index declined 1.4% on the month. Most currencies firmed against the greenback. The euro rose 1.8% and the Swiss franc 0.7%. The rand, however, lost 2.4% against the dollar in January, amplifying the strong offshore markets returns in rand terms. The weaker dollar supported prices across the commodity complex and most of those prices ended the month higher, too. The copper price rose 9.7% and the iron ore price 11.3%, although their prices were boosted by expectations that the lifting of the harsh lockdown restrictions in China would eventually lead to increased demand.

Turning to global equity markets, the MSCI World index rose 7.0% and the MSCI Emerging Market index 7.9%. The Hong Kong market continued its recovery (partly on the back of the "China re-opening" story, too), rising 10.4% in January. The German market rose 8.7% and the US market 6.3%. The tech-heavy, growth-share-oriented NASDAQ index rose 10.7%, reducing its annual loss from -33.1% in December to -18.7% in January. The Swiss equity market rose 5.2%. The US Mid and Small cap indices rose 9.1% and 9.4% respectively.

January thus proved to be a very profitable month for those who were invested in equity markets.

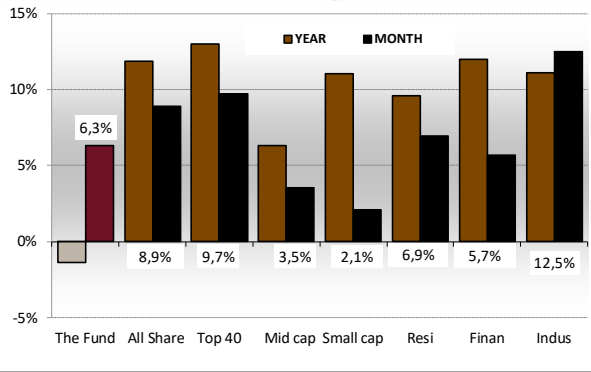

Local market returns

Despite the unique economic and political challenges facing South Africa, local markets followed global markets and posted reasonable gains; the All Bond index rose 2.8% in January and the All Share index 8.9%. The Large, Mid, and Small cap indices posted gains of 9.7%, 3.6% and 2.1% respectively. The Basic Material, Financial, and Industrial indices gained 6.9%, 5.7%, and 12.5% respectively. With January a thing of the past, the annual return of the SA equity market rose from 3.6% in December to 11.8% in January.

Investment Manager comment

The Maestro Equity Prescient Fund rose 6.3%, lagging the 8.9% All Share index return. Capitec declined 3.6% during the month, Stor-Age fell 2.3%, and Cashbuild 0.8%. Naspers rose 18.5%, however the Fund has no exposure to Naspers, or Prosus for that matter. On a more positive note, Afrimat rose 8.9%, Renergen 10.4%, Aspen 10.9%, Discovery 11.9%, Ninety One 13.6%, BHP Billiton 14.7%, Sasol 16.3%, and Richemont 18.3%.

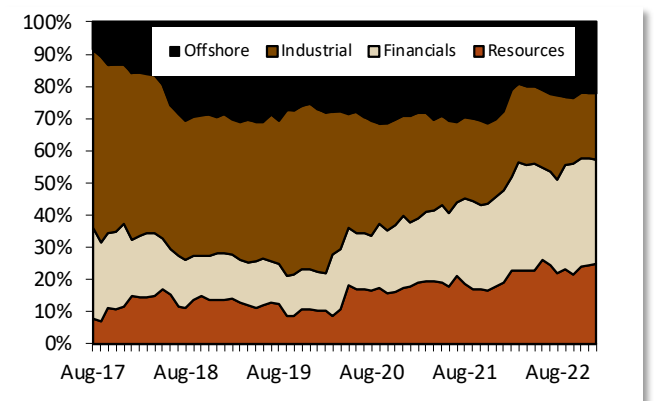
At the end of the month 88.0% of the Fund's assets were committed to the equity market, while the balance of 12.0% is being retained in cash.

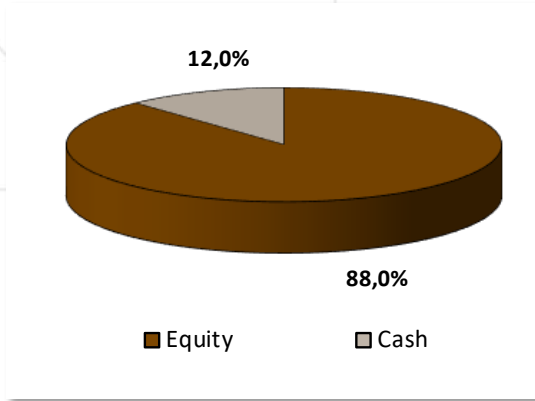
Historic sector allocation (% of Equity)



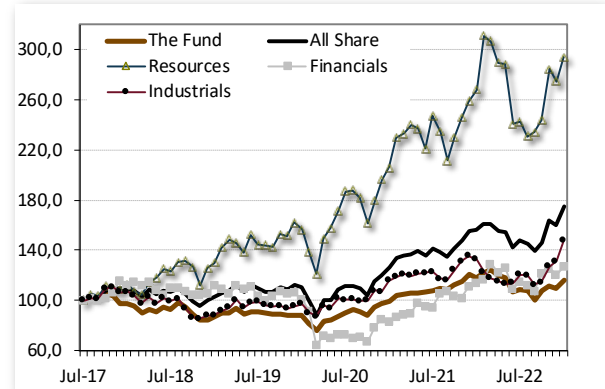
