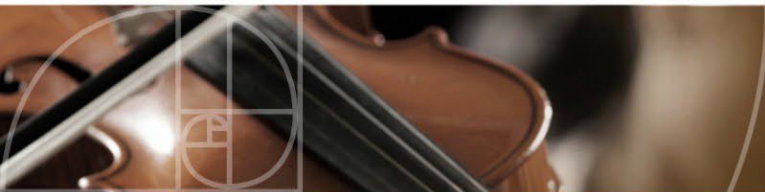

Minimum Disclosure Document & General Investor Report

Investment objective

The Maestro Equity Prescient Fund will be a general equity portfolio. The Manager in selecting securities for the portfolio will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Maestro Equity Prescient Fund, shall comprise a mix of securities, financially sound ordinary shares, stock, financially sound preference shares, debenture stock, debenture bonds and unsecured notes as defined in the Act and the Deed, all to be acquired at a fair market value.

The Fund benchmark

The Fund will measure itself against the FTSE-JSE All Share Index.
ASISA Classification: South African-Equity-General.

Legal structure

The Fund is a scheme in the nature of a trust known as a collective investment scheme. The portfolio manager is Maestro Investment Management (Pty) Ltd, an approved Financial Services Provider in terms of the Financial Advisory and Intermediary Services Act, operating under license number 739. This portfolio operates as a white label fund under the Prescient unit Trust Scheme, which is governed by the Collective Investment Schemes Control Act.

Fee structure

The maximum initial fee is 2.0%. The annual investment management fee is 1.75%. The annual total expense ratio (TER) for period ended 30 June 2023, in respect of class A was 2.28%.

Market Overview

One of the most interesting developments in the investment world of late has been increasing evidence of a resilient US consumer and hence also the US economy. This was met, rather counterintuitively, by another Federal Reserve interest rate increase. Other central banks continue to raise interest rates, although the central bank of Brazil became the first in this interest rate cycle to lower their official interest rates.

In general, we have been satisfied and, in some instances, pleased by the results of the companies in which we are invested, although we note the conspicuous absence of any meaningful clarity about the prospects for the remainder of the year. Not surprisingly, equity markets seem to be losing a bit of momentum, and the gradual but steady increase in bond yields (and decline in prices) is adding to the nervousness.

Bond markets are starting to pre-empt a decline in US interest rates, which in turn led to a weaker dollar in July. The Bloomberg Global Aggregate Bond index rose 0.7% during July. The weaker dollar boosted emerging equity and currency markets; the dollar declined 1.0% and the MSCI Emerging Market index rose 5.8%. Developed equity markets, as represented by the MSCI World index, rose "only" 3.3%, which still represents an impressive result given how strong (17.7%) the index has been so far this year. The Hong Kong equity market rose 6.2% off a very low base, the US market rose 3.2%, and Germany 1.9%. The Swiss market, a typically defensive one, rose only 0.3%. Global tech shares continued to display remarkable strength, with the NASDAQ rising 4.1%, bringing its year-to-date gain to 37.1%. Evidence of an increased appetite for risk can be seen in the monthly gains of the S&P Mid and Small cap indices of 4.1% and 5.4% respectively.

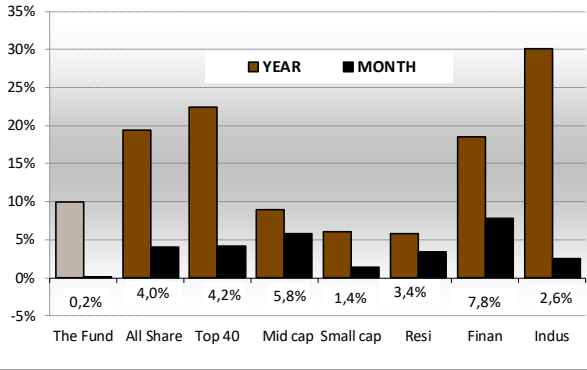

Local market returns

The weak dollar and a partial recovery off a low base helped the rand gain 6.2%, bringing its two-month gain against the greenback to 11.4%. The JSE All Share index rose 10.5% in dollar terms during July, and 4.0% in rand terms. The Financial sector was the main beneficiary, rising 7.8%. The Industrial and Basic Material indices rose 2.6% and 3.4% respectively. The SA bond market benefitted from the prevailing environment; the All Bond index ended the month 2.3% higher.

Investment Manager comment

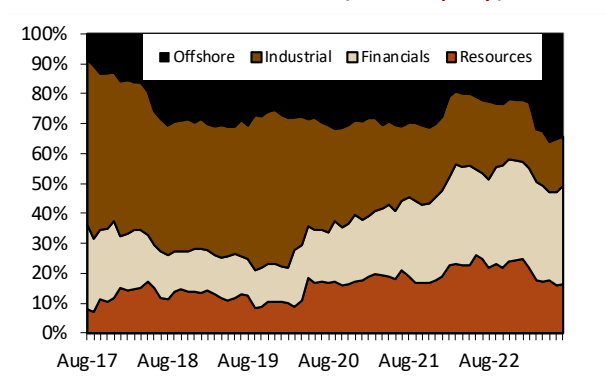
The Maestro Equity Prescient Fund rose 0.2% during July, versus the 4.0% All Share index return. This result was largely a function of the Fund’s large offshore exposure, which was negatively affected by the firm rand. Decliners during the month included Renegen, which lost 10.2%, and Richemont, which lost 10.1% on the back of lower-than-expected results and the effect of the strong rand. Stor-age lost 3.8%, the Sygnia iTrix MSCI US ETF 2.7% and the CoreShares S&P500 ETF 2.6%. Moving to the gainers during July, Aspen rose 4.4%, Firststrand 6.3%, Standard Bank 7.6%, Discovery Holdings 8.3%, and Capitec 14.4%.

The Fund has adhered to its Policy objective during the month.

Historic sector allocation (% of Equity)



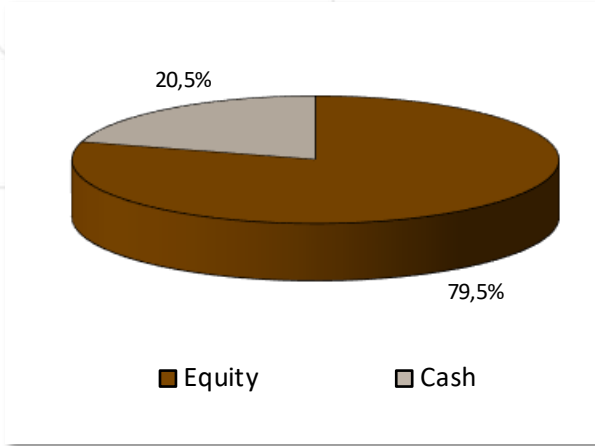

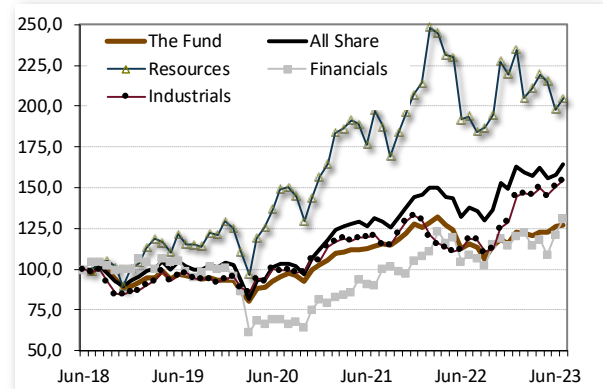
