## Minimum Disclosure Document

### Investment objective

The Maestro Equity Prescient Fund's objective is to produce above average long-term returns by investing in the South African equity market. It will simultaneously aim to assume less risk than the risk inherent in the market itself. The Fund adopts a conservative investment philosophy. The Fund falls under the South African Equity General ASISA classification as the Fund has a high risk profile.

### The Fund benchmark

The Fund will measure itself against the FTSE-JSE All Share Index

### Legal structure

The Fund is a scheme in the nature of a trust known as a collective investment scheme. The portfolio manager is Maestro Investment Management (Pty) Ltd, an approved Financial Services Provider in terms of the Financial Advisory and Intermediary Services Act, operating under license number 739. This portfolio operates as a white label fund under the Prescient unit Trust Scheme, which is governed by the Collective Investment Schemes Control Act.

### Fee structure

The maximum initial fee is 2.0%. The annual investment management fee is 1.75%. The annual total expense ratio (TER) for period ended 31 March 2017, in respect of class A was 2.2%.

## Market Overview

International markets continued their strong momentum into May as positive economic data released in key economies around the world added further fundamental support to rising markets.

The MSCI Emerging Market index rose 2.8%, while the MSCI World index rose 1.8%. Emerging markets have managed to outperform developed markets each month this year. The Greek equity market rose 8.9% and Turkey 3.1%, despite all that is taking place in those economies. The Indian equity market rose 4.1% but the Chinese market fell 1.2%. Within the developed market space, the Hong Kong market surged 4.3%, while the German and the US market each gained 1.3%. Tech shares drove much of the gains once again: the NASDAQ ended the month at an all-time high, having gained 2.5% on the month and 15.2% so far this year.

Global bond markets enjoyed a profitable month. The Bloomberg Barclays Global Bond index rose 1.6% and the equivalent US index rose 0.8%.

The US dollar was again weak in May as it declined 2.1% against a basket of currencies. The euro gained 3.3% against the greenback, while sterling declined 0.2%. Despite the weaker dollar, commodity markets were on the back foot too: oil continued its slippery slide downhill, ending the month 1.8% lower. Oil has managed to decline each month this year, bringing the year-to-date loss to 10.1%. Copper declined 0.8% and nickel 5.3%, but it was iron ore which again grabbed the most attention, ending the month down 14.7%.

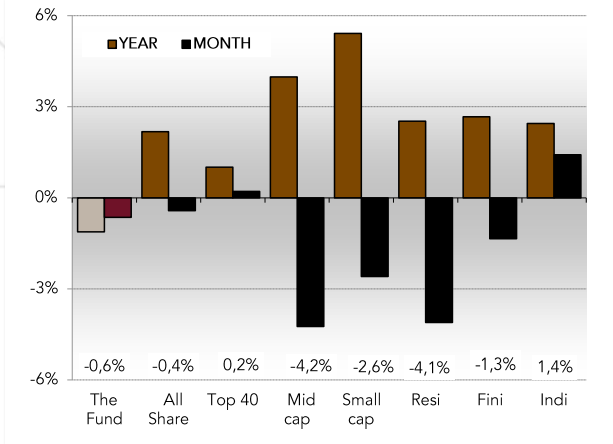

**Local market returns**



Turning to local equity markets, the All Share index (Alsi) ended 0.4% lower, thanks largely to the weaker commodity complex. The Basic Material index declined 4.1%. The Industrial Index rose 1.4%, boosted by another strong performance in Naspers (up 7.1%), again highlighting tech strength. The Mid-cap and Small-cap indices declined 4.2% and 2.6% respectively. The Financial Index declined 1.4%, on the back of a strong (3.6%) performance last month, while the All Bond index rose 1.0%, in line with global bond markets.

**Investment manager comment**

The Fund declined 0.6% during the month. Although the Fund has an underweight position in resource shares, which declined during the month, weakness in certain holdings contributed to the slight underperformance relative to the index. The laggards included Consolidated Infrastructure Group, which fell another 16.4% following on from their disappointing results last month. Sygnia fell 14.7%, EOH 11.1% (after reshuffling their board and the departure of their long standing CEO), while Mr Price and KAP both declined 4.5%. On a more

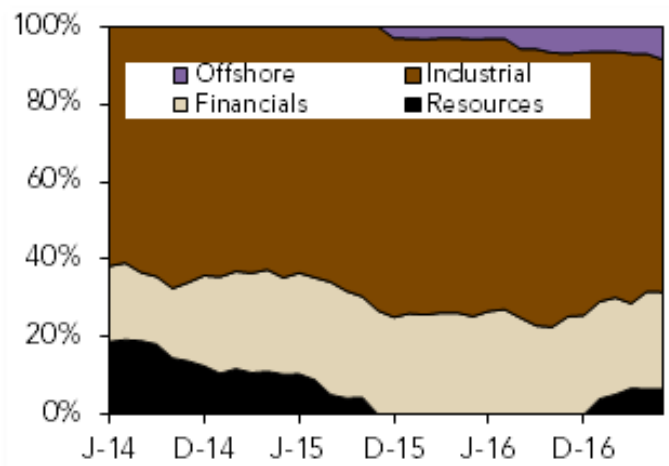
positive note, holdings which delivered above-average returns on the month included Aspen, which rose 7.4%, while Naspers gained 7.1%. Echo Polska Property, our latest addition to the Fund, rose 2.5%, as did Steinhoff International.

**Historic sector allocation (% of Equity)**

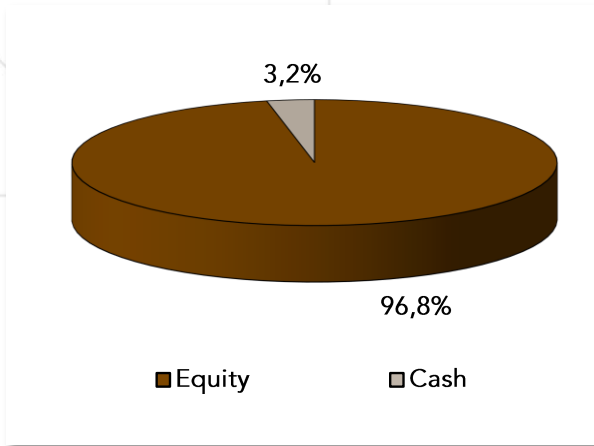

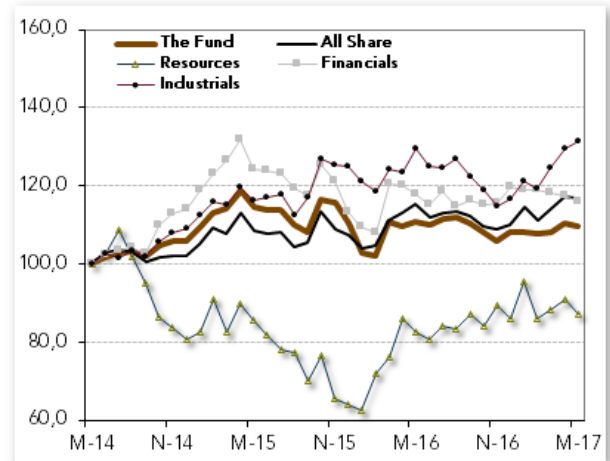

## Disclaimer
